Meeting Opened: at 7:30 pm

Mr. Barrasso welcomed all to the meeting.

Opening Remarks: Mr Lombard stated that spring clean up has begun around town and welcomed Jeff to his first Selectmen's meeting and Mr Manning is participating via Skype. Mr Barrasso stated the DPW will be sweeping the streets.

Approval of Prior Meeting Minutes: Mr. Manning made a motion to approve the 3/19/15, seconded by Mr Lombard, it was a unanimous vote in favor.

Citizens Forum: Old Business-Chip Sealing: (Inaudible by a Town resident who did not approach the microphone and identify himself). Mr Barrasso stated that based upon last years paving program the chip seal was recommended and applied and based upon a petition of the residents of these roads the Board is trying to address and fix this situation and try to come up with a plan. Stating a process needs to be followed before we can fix the roads. Mr. Barrasso explained this process. Mr Chelgren stated the loose aggregate will be removed and suggested Cape Seal be applied and should seal everything in. The residents did not agree with this application. After input and questions from the residents, answered by the Board and the Town Administrator, Mr Lombard made a motion to direct the Town Administrator to add the chip sealed streets to our Chapter 90 street list to be ground and hot topped to be bid on, Seconded by Mr Barrasso, for discussion, to get two separate bids for Cape Seal and milling and repaving. Mr Chelgren stated these bids will be just for Maolis Rd. It was a unanimous vote in favor.

John Burwell of One Goddard Drive stated that behind his house near the bunker there is broken pavement that is seeping tar into the ground and requested it be removed. Mr Barrasso stated it will be looked and removed as soon as possible.

Town Administrator Report:

FY16 Budget and Warrant: Mr Chelgren stated the FinCom Warrant book went to print and will sign the warrant tomorrow. Mr Manning made a motion to have the Town Administrator post a copy of the warrant book on the Town's website, seconded by Mr Lombard, it was a unanimous vote in favor.

Town Counsel Report: Mr. Riley stated that he visited the properties with the Town Administrator to familiarize him with this situation.

Closing Announcements: Mr Barrasso read the closing announcements as presented.

Adjourn: Mr. Barrasso made a motion to adjourn. Mr. Lombard seconded the motion. Meeting adjourned at 8:45PM.
