**1. Meeting Opening 7:30 pm**

Pledge of Allegiance – Led by Mr. Barile

- a. Opening Comments – The Board expressed their sympathy on the passing of Ray Baron
- b. Approve Prior Minutes of 10-19-17 and Ex Minutes of 10-24-17 and Ex Minutes of 9-27-17 – Mr. Lombard made a motion that the Board of Selectmen vote to approve the Minutes of 10-19-17 and Ex Minutes of 10-24-17 and Ex Minutes of 9-27-17. Mr. Taylor seconded the motion. Unanimous vote to approve.

**2. Ongoing Business**

- a. **Citizen's Forum** – None
- b. **Kite Surfing** – Police and Fire Chief Comments – Chief Dwyer gave kudos to Chief Feinberg for drafting the policy. He recommends educating the police and fire about kite surfing and putting in place rules and regulations. Doggy Beach is the safest beach to make rescues. Chief Feinberg stated that the majority of water rescues were boaters. Only one kite surfer call – it was an abandoned board that they were informed about. Mr. Lombard made a motion that the Board of Selectmen authorize kite surfing on Doggy Beach. Mr. Taylor seconded for discussion. Mr. Barile trusts that Dylan Dobbins and the Chief will work together to establish policy. Unanimous vote in favor. The Board thanked Mr. Dobbins for his work for the surfer community and he thanked the Board.
- c. **Fire Station Assessment** – Mr. Barile is concerned that the new fire engine that is coming needs covered shelter so we need a short term plan to address this. Mr. Lombard said the town needs a new fire station and we should spend the money to make it right and put article in warrant for Town Meeting. Mr. Taylor agrees with both – need both a short and long term solution. Mr. Walsh, chair of Fire Station Assessment Committee says committee is meeting regularly and will have recommendations next at next BOS meeting.
- d. **Winter Parking Ban** – Mr. Barile read the Parking Ban Policy (attached). Chief Dwyer said the department uses a common sense approach and works with residents during snow and ice events. Mr. Lombard is in favor of flashing blue lights. Chief states that the current policy works, has been in place for years and he recommends keeping it in place as is. Mr. Lombard made a motion that the Board of Selectmen vote to approve the winter parking ban from 12/21/17 to 3/20/18 from 12AM to 6AM. Mr. Taylor seconded the motion. Unanimous vote to approve.
- e. **Trash Collection Communication (new web complaint email)** – Mr. Chelgren stated a complaint form has been added to Nahant.org for trash complaints at the request of the Board to

improve communications between Waste Management and the Board. For residents without a computer, Waste Management's and the Police Number will scroll on CATV.

**a. Event Request – Johnson School Holiday Concert** 12/20/17 7PM Town Hall – Mr. Taylor made a motion that the Board of Selectmen vote to approve the event request for Johnson School concert. Mr. Lombard seconded the motion. Unanimous vote to approve.

## WELCOME TO OUR WINTER PARKING INFO PAGE | 2017-2018



The Town of Nahant has a **Winter Parking Policy** stating that all vehicles must be parked off the street during the hours of **12AM - 6AM from December 21, 2017 to March 20, 2018**

If you are a resident of Nahant and do not have adequate off street parking, you may pick up a **Parking Waiver Application** at the **Nahant Police Station**. Once the application is submitted and reviewed you will be notified upon its approval.

1. A \$30.00 nonrefundable application fee is required in order to process each request for a parking waiver. This fee must be paid by check or money order only and made payable to the "Town of Nahant" prior to review of the application. **Cash Will Not Be Accepted.**
2. All vehicles at the residence must be registered to that address. If there are two off street parking spaces, but there are three vehicles at the residence, all three must be registered to that address in order to qualify for one waiver permit needed for on street parking. Commercial or lease vehicles must have the operator/lesser residing at that address.
3. Persons applying for a parking waiver permit **Must** get off street parking when it snows or when a snow emergency has been declared due to a forecasted snow fall. *ICE OR*
4. All vehicles, **With or Without** a parking waiver **Must** be off the street when it snows or when a snow emergency has been declared due to a forecasted snowfall. *there is an ICE storm, or OR ICE*
5. Any vehicle left on the street during a snow storm (whether a declared snow emergency or not) will be subject to a fine for impeding Snow Removal, which is \$50.00. In addition, the registered owner will also be subject to a towing charge when the vehicle is removed from the street.
6. Violations (such as impeding snow removal) will result in a review and possible **Revocation of the Parking Waiver**
7. All three Town Departments (Police, Fire and Public Works) must approve the parking location selected by the applicant. Should any on of the departments reject the location selected, the application will be returned to the applicant so they can find a suitable area to park
